WHAT DOES COLLEGE RAPTOR DO WITH YOUR PERSONAL INFORMATION?



Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do. Information contained in this notice is not applicable to information provided by users of a Net Price Calculator viewable from a licensee institution's web site. Institutions license the Net Price Calculator from College Raptor, and neither creditworthiness information nor other non-public personal information submitted on a licensee institution's Net Price Calculator is shared by College Raptor with affiliates or non-affiliates except for the licensee institution itself.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Financial Information
- Account Information
- Name, email address, home address, and telephone number

How?

All financial companies need to share customers' personal information to run their everyday business. College Raptor, Inc., and all other College Raptor websites, like ShoppingSheet.com, and Raptorfi.com (together, "College Raptor").

What we do

How does Citizens protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Citizens collect my personal information?

We collect your personal information, for example, when you

- Open an online account.
- Utilize our tools, such as College Match, Student Loan Finder, or search for Scholarships.

We also collect your personal information from others, such as affiliates or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- Sharing for affiliates' everyday business purposes—information about your creditworthiness.
- Affiliates from using your information to market to you.
- Sharing for nonaffiliates to market to you.

State laws may give you additional rights to limit sharing. See below for more on your rights under state law.

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Citizens JMP Group LLC

Nonaffil<u>iates</u>

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

• We do not share with nonaffiliates so they can market to you.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

• College Raptor does not jointly market.
